For the position advertised at serial number 1 and 2 eligible candidates are advised to submit filled application form attached in annexure 1 along with declaration form (Annexure-II) and scanned copy of the original documents as a **single PDF** through email to recruitment.nisa.ranchi@gmail.com on or before 03.01.2025. Only the shortlisted candidates who are communicated through email shall attend the interview (only offline) on the scheduled date mentioned above.

The venue of the interview will be ICAR-National Institute of Secondary Agriculture, Namkum, Ranchi 834 010 (Jharkhand). Shortlisted candidates are mandatorily required to carry a copy of the submitted application form along with original testimonials for verification. If any candidate is found to have submitted false claims during screening or at later stage, their candidature will be summarily rejected.

The above positions are purely temporary and coterminous with the projects. Candidates shall be appointed on contractual basis initially for a period of 1 year extendable thereafter purely based on satisfactory performance. The selected candidate shall not claim any regular appointment at this institute or at ICAR at the end of contract. The competent authority will have the right to terminate the appointment at any time without assigning any reason/notice whatsoever.

Candidates whose near/distant relative(s) is an employee of the ICAR-NISA, has to declare it and communicate this office as per format given below (Annexure-II) before the date of interview. No TA/DA will be paid by the institute to the candidates for attending the interview. Non-maintenance of the discipline and failure to perform the assigned duties will make the contractual person liable for termination during the appointment period as per ICAR rules. Canvassing in any form will lead to disqualification. In case of any disputes, it will be resolved in the jurisdiction of Ranchi (Jharkhand) court only. A qualifying test (written) may be conducted before interview as decided by the competent authority.
